Special thanks go to the retiring Executive Board for their dedicated service and particularly to our former President, Dan Seelye. He served 4 years and hosted the Tacoma, WA., SGS 2001 Reunion. As the incoming President, I had the pleasure to present a corsage of gratitude to Dan's wife, Ruth, for her support of Dan and the SGS. Marshall Seelye presented a plaque to Dan as a token of the Society's appreciation for his outstanding efforts. Dan presented the Society a gavel to be passed along for use by future SGS Presidents.

I will continue to coordinate SGS Queries as I have in the past. Ann Hall, the new Chief Genealogist will pursue other initiatives. Omitting the normal query column was considered in this issue, dedicated to the victims of the 11 September attacks; however, some queries were received several months ago, and waiting until the February Newsletter seemed unfair. So, queries and query updates received up to the SGS Reunion are included in this issue. Those submitted for posting at the Reunion and subsequent will appear in the February Newsletter.

REACTIONS TO TERRORIST ATTACK

The following SGS members have expressed their reactions to the Terrorist Attack on September 11, 2001. They are reprinted below as indicative of the feelings of SGS members and U.S. citizens:

James R. Seeley: My reactions to the Events of 11 September were disbelief that such a terrible act could happen; anger at those responsible, followed by grief for those lost or injured followed the tragedies of 11 September. My emotions were on a roller coaster watching the events unfold. One of my major early concerns was that our Nation be careful how we respond so we don't generate more hatred that could precipitate more attacks in future years against our families and loved ones. I have been a strong supporter of the response our country has taken so far. We seemed to have carefully considered who organized those terrorist attacks and the actions we have taken so far (at this writing) have been those that minimize injury to innocent people. At the same time, we are providing aid to those poor refugee Afgans not only for strong humanitarian reasons, but also to minimize the hate factor toward Americans. In our grief, we are sustained by the care we share for each other, our spiritual beliefs, and the courage we inherited from our ancestors. I believe our Society's work in better understanding our family heritage can add to the strength we all need. Certainly, these hard times demand the best from all of

<u>Update to Query # 0108-9</u>: (August Newsletter) The submitter was Bob Sasman, Email <u>marbo16@core.com</u>. Bob sought information regarding the Seelye stone house and "Owl's Nest" at Joshua's Rock, on the shore of Dunham's Bay, Lake George, Queensbury, NY. While attending the SGS Reunion at Tacoma, Leslye Teuber replied via Dan Seelye as follows: "Francis Seelye is the sister of my great, great grandfather, Darius Seelye. Elwin Seelye, a brother of Francis married Elizabeth Eggleston, daughter of Dr. Edward (Eggleston). The home was built by the Eggleston Family. They had three children Elwyn, Allegra, and Maude.

"Joshua's Rock is on Lake George, Warren County, NY. The home is on the National Historic Register. There is a library on the estate, plus other lodgings. The home is now owned by the descendants. <u>d0030/13424.HTM</u> in his will, P.T. Barnum disposed of an estate of \$4,100,000, and he made careful provision for the perpetuation of his name. Since he had no sons, he provided that his grandson, C. H. Seeley, should receive the sum of \$25,000 besides his share in the estate, if he would change his name to C. Barnum Seeley, "so that the name of Barnum shall always be known as his name."

SGS Response: John Seely, SGS Database Coordinator, responded to Brian that he had a Clinton Hallett Seeley in his database. He was born in Bridgeport, CT 10 Aug 1867 and died there ca 1958. He married Florence Tuttle 30 Dec 1896, possibly in New York City. John had no dates or places for Florence. Some of the above came from an obituary of Herbert Barnum Seeley in 1914 from the ST PAUL DISPATCH and a book THE FABULOUS SHOWMAN, P.T. BARNUM, p. 172. John also shows Jesse Barnum Seeley as a sibling of Clinton. A sincere WELL DONE to John Seely for tracking down the information Brian Smith requested. John said many members have heard "something" about a Seeley connection to P.T. Barnum and this could correct any misconceptions although stories are good for the soul.

Louise requests assistance in determining the death of Benjamin Sealy, who m. Elizabeth SOLDS, widow (per a New York license dated 23 Jan 1773). Louise believes this couple was probably married in Hempstead (Nassau) NY or perhaps Weston (Fairfield) CT and that the printed version may be inaccurate and that SOLES is meant for Elizabeth.

Louise is also seeking information on the birth and death of this Elizabeth, who may have been a widow of Benjamin Soule from Dutchess Co., NY(?). Louise also wants to know if Elizabeth had any children by Benjamin Sealy.

SGS Interim Response: John Seely responded that the SGS 6th Generation Book lists a Benjamin Seeley "(b abt 1756 Weston, CT) m 23 Jan 1773, NY, Elizabeth Scolds. Resided VT. Moved to Canada. Had sons." The SGS Publications do not list a date of death for Benjamin Seeley nor does they list birth or death dates for Elizabeth Scolds. Jim Seeley replied to Louise by letter with the interim response and with information on joining SGS. SGS Interim Response: Dan Seelye responded that this Harriet Seeley is listed as SGS # 956 (7th generation in the Nathaniel line), daughter of Nathaniel Seelye and Rebecca Goodspeed. This entry in the SGS Seventh Generation Book states only that there were children born to this couple. She has been trying off and on for years to find, for a friend, the line of Henrietta Timm Seely who married 22 February 1870 Henry J. Mumford who was born 23 February 1844. This, plus the fact that they had a son, Leon Orville Mumford, born 5 January 1871, is the sum total of her information. Henry J. Mumford's father was of Otsego County, NY. The son, Leon, resided in Summit, NJ in 1931 and 1943. Marian is seeking information on Henrietta's line.

SGS Interim Response: A review of the 3 SGS Publications found no good match. However, a remote possibility could be SGS # 2992, this "Henrietta Seeley (b 29 Dec 1843; d 27 Feb 1902) m Mr. Williams" is about the right age to have born a son in 1871 but it would have been in a different marriage. This Henrietta is 8th generation, dau of Ebenezer Seeley in the Ebenezer, Enos, David, John, Nathaniel, Robert line. Clearly, more research is needed. Subject: Ruth Seeley

Robin believes she might be related to a Ruth Seeley who married an Abijah Hall in 1789. Supposedly they had a Seeley born in 1790 and an Ira born in 1792. She believes they may have more children. She has an unproven birth date for Ruth Seeley of 25 Sep 1765. She has circumstantial information on Ira S. Hall indicating he is the son of Abijah and Ruth. She believes Abijah is the son of John Hall and Abigail Shepard who resided in Middletown Ct. In 1790 Abijah is living in Chatham, Ct. with a wife and one child. Abijah is also residing in Chatham in 1800, 1810. Abijah's birth date is 31 Jan 1747/8. Robin then finds her GGGGrandfather Ira S. Hall in Seneca Co., N.Y. in 1820 and Wayne Co., NY in 1830. Ira Hall then moves to Michigan sometime in the early 1830's. Robin has been unable to determine whom Ruth Seeley's parents are, where she was born or if there is any record of their marriage or her birth. Can SGS help? Ruth has been through the Barbour collection.

SGS Interim Response: The SGS Publication Generations One Through Five lists a Ruth Seely (b. 6 Sep 1765) who has siblings living in Norwalk, New London Co., CT. However, it contains no additional info. This was the closest match found. This query was received too late to obtain inputs from the SGS Query Team. SUMMARY OF REUNION 2001 Tacoma, WA September 6-9, 2001

The 2001 Reunion of the Seeley Genealogical Society was preceded by an all-day bus tour of the Tacoma area. Twenty-nine reunion attendees were treated to views of the period architecture of downtown, and to noteworthy homes including the boyhood home of Bing Crosby. After a pleasant luncheon at a waterside restaurant on Point Defiance the tour continued through Point Defiance Park, past the infamous "Galloping Gertie" (Tacoma Narrows Bridge) to the quaint village of Steilacoom, Washington's oldest incorporated town (founded 1854), where the group was treated to a walking tour of the oldest homes. The tour was concluded by a very interesting tour and explanation of the Tacoma Port, one of the largest container handling ports in the world. Various types of container ships and the container handling systems were shown and explained to the group.

Daniel Seelye opened the Reunion at the Business Meeting on September 7, 2001. During the Business Meeting the Secretary's and Treasurer's reports were approved, and the Membership Chairman, George Seeley, reported current membership at 384, of which 93 are Life Members. James Seeley discussed the proposed concept of Area Coordinators, and presented a draft of a new brochure being drafted to describe the SGS and to aid in recruiting new members. Katherine Olsen reported that the Seventh Generation Book was almost sold out and proposed having it reprinted. (Reprinting was later approved, and since the reunion 100 additional copies have been provided to the Seelye Research Center.) She also discussed the need for documentation guidelines for any proposed changes or corrections for the three SGS publications. Terry Tietiens reported that the Research Center is "doing well" but could use both more research visits by members, and volunteer help to organize the material. The Nominating Committee presented their proposed slate of officers, all of whom were elected. (See page 2 of this Newsletter for the current list of Officers.) Following election of officers for the 2001-2003 term, the location for the 2003 Reunion was selected as Williamsburg, VA., and James Seeley's offer to host the Reunion was accepted.

The guest lecturer, Janet Nixon Baccus, presented three very interesting sessions. These sessions were entitled: "Workshop on Beginning Genealogy," "What is Available in the Local Area," and for her banquet talk, "Coast to Coast in 50 years," her own genealogical research.

On Saturday, September 8, James Seeley presented issues that he had developed during his term as Chief Genealogist for the SGS. These issues are separately discussed elsewhere in this Newsletter. Daniel Seelye presented a session on "Hardware and Software Needs for Genealogy." During the afternoon "wrap-up" meeting, Katherine Olsen suggested that we continue the research Fred Hart has started to attempt to define the ancestry of Obadiah, pursuing it into England if necessary.
