# **Highlights of the 2011 SGS International Reunion**

The Seeley Genealogical Society convened for its biennial meeting at the Hilton Garden Inn Elmira/Corning in Horseheads, N.Y. Thursday, July 14, 2011 through Sunday, July 17, 2011. There were 69 registrants and at least 90 attended the various reunion events.

Registration began at 9 a.m. on Thursday. The registration committee was made up of Camille Seeley Bell, Thera Seeley Clark, Janet Daniels, Joan Kingsbury, and Lynda Simmons who greeted all attendees warmly and took care of many financial issues and other questions. The Hospitality Room was opened for members to display documents, and artifacts and to visit with one another.

The SGS Board of Directors, including both elected and appointed officers, met at 10 am. Minutes of the meeting will be published in the November issue of the SGS Newsletter, however highlights can be found in the SGS President's Report in this newsletter on page 2.

The reunion's opening session was brought to order by SGS President Kathie Olsen at 1 p.m. She introduced the leader of the hotel's event staff, Shauncey Howard, who welcomed the attendees. Attendee feedback regarding the hotel and its staff was universally positive.

The SGS Board of Directors was introduced and thanked for their dedication and service. The committee that put together the reunion was also thanked for all their hard work which made the reunion possible. Members serving on that committee included Eugene Seelye, Jim Seeley, Linda Crocker, Laura Condie, Veronica Seeley Newell, Sally Seeley, George Seeley and Kathie Olsen.

Brief reports were given by several board members concerning the 2011 Reunion Souvenir Book, SGS publications for sale, CD sales, the possibility of a 2014 tour to England, and DNA testing.

Those were followed by Reunion Keynote Speaker Kerry Lippincott, education coordinator of the Chemung County Historical Society. Her theme: "Overview of the History of the Area, including Seeley Family Settlers."

At the conclusion of Lippincott's talk, SGS Members Jesse and Lou Ann Crisler, former members of the Mormon Tabernacle Choir, introduced and then performed the reunion theme song. It was sung to the tune of the Rodgers and Hammerstein hit *Oh, What a Beautiful Mornin'* from the soundtrack to *Oklahoma!* The words, written especially for the reunion by Jesse and Lou Ann can be found on page 4 of this newsletter.

# **SGS President's Report**

We had a wonderful conference at the SGS 2011 Reunion in Horseheads, N.Y. We learned about Tioga, Bradford, and Chemung Counties in New York and Pennsylvania through which so many of our Seeley ancestors passed and which many of our cousins still call home!

The reunion also offered three opportunities for Society business meetings. Our Secretary Mary Palley was there taking notes, but we sabotaged her by not giving her enough time between the end of the reunion and the submission deadline for this newsletter to complete her work. The official minutes of those three meetings will appear in the November newsletter. However, I still want to cover the highlights of the three official meetings that took place during the reunion.



The first was a meeting of the 2009-2011 SGS Board of Directors on Thursday, July 14. Since we didn't meet in Abilene this spring as we normally do, this was our first time together in more than a year (though we've been in near constant contact through e-mail). We began the meeting with reports from the various officers concerning their assignments. Several issues of importance were discussed. I reported that SGS has been named a beneficiary in the estate of Evelyn Johnson, wife of Robert Seeley Johnson who served as an officer in the Society in the late 1970s and 80s. The amount of the bequest will be determined at a hearing in 2012. It was decided to dedicate the conference and the souvenir book to John & Maurine Seely. John passed away in October, 2010 after a long life and continuous service to SGS. Maurine had preceded him in death. Their influence on SGS is far-reaching including the establishment of the SGS Ancestor File Index, serving as officers and always be in attendance at SGS activities! Their son, Robert provided pens and copies of John's poetry book, *Rainbows and Raindrops* as gifts to reunion attendees.

The general membership meeting was July 16. Officers were elected. Marshall Seelye was elected to the position of Second Vice President. All other officers currently serving were re-elected. Special thanks to George Seeley who diligently served as 2nd VP from 2009-11. Thanks also to the nominating committee which consisted of Jim Seeley, LeAnne Seely and Marshall Seelye. The proposed constitutional change as outlined in the last newsletter and the dues increase were both approved. The amended constitution and by-laws appear on page 12. An auditing committee consisting of Margaret Petersen and LeAnne Seely reported that the Treasurer's books are in order. Several places were considered for the 2013 reunion; San Diego, Calif.; Abilene, Kan. and Grand Rapids, Mich. After a discussion, Grand Rapids was selected. Bill Hileman, Marion Hileman, Richard Speer, Anita Speer, Mary Palley, Linda Crocker and others volunteered to serve as a reunion committee along with me as chairperson. The committee will meet in Grand Rapids on Monday, May 1, 2012. If you would be willing to help, please contact me (see contact info on page 15).

The third meeting was of the 2011-2013 SGS Board of Directors and it was held later the same day. The site of the next reunion was discussed. The SGS Ancestor File, which was started by John Robert Seely and has really blossomed with the hard work of Linda Crocker and Chris Havnar consists of two databases; the SGS Seeley Surname Database, which consists of those with any spelling of the Seeley surname, and the SGS Database of Other Surnames, which includes Seeley descendants whose surnames are not Seeley. A committee was formed to set the parameters of the SGS Database of Other Surnames. Camille Seeley Bell and Jesse Crisler will serve on this committee along with Linda Crocker and Chris Havnar, SGS Ancestor File Co-Chairs. The Membership Chair, Lynda Simmons, will prepare a yearly report of paid members and life members and other categories to be published in the newsletter. Jim Seeley and Marshall Seelye will serve as members of an Awards and

Recognition Committee. This committee will be responsible for pursuing both internal and external awards and recognition for the Society. George Seeley will continue to serve on the Constitution and By-laws committee. A History Committee was formed with SGS Historian Ruthetta Hansen as chairperson. Jim Seeley, Dian Little, Wesley Waring have also volunteered to serve on this committee. Since the newsletter production is the major budget item, we discussed ways to bring down the costs including electronic distribution, and publishing fewer issues per year. No decision was made but further

# discussion is in order. Also, the group is interested in finding appropriate research topics to be funded by money in the treasury. If you have ideas on this topic, please let me know. We also briefly discussed the Society's membership in both the Federation of Genealogical Societies (FGS) and the National Genealogical Society (NGS). ## **SGS DNA Project Update**

The Relative Genetics DNA Laboratory was recently taken over by the DNA Heritage Laboratory. Now the DNA Heritage Laboratory has been taken over by the Family Tree DNA Laboratory. As a result of these changes, the SGS Seeley Surname Project got lost and privacy rules were ignored.

If you want to have a DNA test done to determine if you descend from immigrant Robert Seeley or immigrant Obadiah Seeley (or neither), please contact me, (see contact info on Page 15). I will recommend a laboratory to do your test. You should order a 37 marker Y-Chromosome test in order to compare your results with the DNA profile we have for immigrants Robert and Obadiah Seeley. The Y-Chromosome is passed only from father to son, so only males with a Seeley (spelled a variety of ways) surname should apply for the test. The 37 marker test had been costing about \$149, but one lab recently

advertised a special for \$119. There is no SGS mark-up.

I will determine if scaling factors need to be applied then compare your results with our ancestor's profile. I will also protect your privacy by using some of your ancestor's names before posting your results on the Seeley website. That way, some of your cousins may decide they don't need to take the test. So, when you receive your results, send them along to me.

If you've had a Y-Chromosome test done by another laboratory and your results have not been analyzed to determine if you belong to the Robert or Obadiah Seeley DNA profiles, send your results to me and I will do that for you. As usual, I may need to apply scaling factors so your results can be compared.

I'm still looking for a volunteer to assume the SGS DNA Project Manager position. Please contact President Kathie Olsen or me.

# **SGS Launches Facebook Page**

The Seeley Genealogical Society is now on Facebook. If you're on Facebook, you should become a fan. You can find the page at <a href="https://www.facebook.com/seeley.society">www.facebook.com/seeley.society</a>.

Genealogists have long been at the forefront of leveraging the power of technology to improve their craft and increase the yields of their research. The internet has been a boon to family history researchers and most people interested in genealogy have already taken the plunge into the online world. With that in mind, a decision was reached at the last reunion for the society to engage in the social media as a way of sharing information and, perhaps more importantly, increasing awareness of the society and hopefully increasing membership.

If you're new to the world of Facebook and are not sure if you should take the plunge, your reticence is understandable. There are headlines every day about identity theft. While those stories are often real, there are measures one can take to protect oneself online and on Facebook.

The U.S. Navy has a free and publically accessible step-by-step guide on how to manage Facebook privacy settings. It can be found online at <a href="https://www.slideshare.net/USNavySocialMedia/facebook-privacy-settings-february-2011">www.slideshare.net/USNavySocialMedia/facebook-privacy-settings-february-2011</a>. The guide was designed for Sailors to help them protect not only their privacy and identities, but also

national security. So it is designed to set Facebook security features to their highest settings. Even if you're already on Facebook it's a good idea to look at this guide and review your privacy settings and to continue to do so every six months or so as Facebook's security features change and are upgraded frequently.

You are invited to post information to the SGS Facebook page. However, that information will only be seen by people who visit the page. That's a good approach if you have a specific message for the person or organization on which you're posting. However, the power of Facebook is its ability to "broadcast" posts to all the people who are friends of a page. That happens when a note is posted by the page's owner on their own page: that information goes into the "news feeds" of every one of the page's Facebook friends -- the note goes to them rather than waiting for them to come to it.

So if you have a note or item of interest you would like to share with all SGS Facebook fans, e-mail it to SGS Facebook Administrator Paul Taylor at <a href="mailto:paul.taylor.va@gmail.com">paul.taylor.va@gmail.com</a>. He can post it to the SGS Facebook page for you. That way it will go into the news feeds of all the page's fans, thus going to them rather than waiting for them to come to it. But remember: no more than 420 characters including spaces!

# SGS CD-ROM Updated

The SGS CD-ROM (see the back cover to order) has been updated with the latest version of the SGS Ancestor File (Version 2011). Within it you will find two databases. One is the SGS Seeley Surname Database and the other is the SGS Database of Other Surnames. Both are indexed according to given name and also according to mother's name, and both appear in multiple formats (xls, doc, txt and pdf). The SGS Seeley Surname Database lists over 28,000 individuals born with the surname Seeley (any spelling). The SGS Database of Other Surnames lists more than 11,200 descendants of Seeley women. Both databases list known birth, death and marriage dates and locations and names of spouse and parents as well as generation number and SGS number (if applicable) and source codes.

The CD also has copies of the three printed SGS publications, a research report on Robert Seeley and two research reports on Obadiah Seeley.

#### SGS E-Newsletter?

# **Seelye Research Center Update**

To those of you who were not able to attend this years' reunion, I thought I would give you the report that was presented at the board meeting.

"Since the last reunion, the society has purchased two 1GB hard drives for storage and protection of our data. These hard drives are located with Chris Havnar and Linda Crocker. Our data is also stored on the computer at the research center and on the librarian's personal computer. Work is still ongoing to get our files indexed and scanned/ digitized. Currently the index for the descendants of the 8th generation is 1.7 MB and contains 13,970 line items. Our scanned files for Nathaniel descendants are 251 MB and 204 files and Obadiah is 177 MB and 144 files (These are the actual copies of our paper files). The backlog of files waiting to be processed is around 600 e-mails from Linda and Chris. Our next big project on the horizon is the files of John Seely. Kathy currently has these boxes and I hope to be able to get them from her before the snow flies. We have no idea what these files contain and how much pertains to the Seeley line directly, but our next meeting will be to determine the best course of action for these files."

There is always a new project to be done at the research center while trying to keep up with what has already been started. Chris and Linda are tireless in their pursuit of information and with more data making its way to the internet they are finding it and tracing it back to a known SGS number if possible. I truly hope that someday the center will be the place for all things Seeley; regardless of the spelling.

### Research Uncovers New Information About 19th Century Seeley Twins

Twins Montraville (SGS# 1676) and Montelion (SGS# 1677) Seeley are listed in the Sixth and Seventh Generation Families of Obadiah Seeley as children of Elizabeth Seeley, SGS# 487. The information states that they were born to Elizabeth before she married Abner Hetfield in 1781. However census information clearly shows that they were born in 1805. Elizabeth was married to Abner at that time.

J. Kelsey Jones, speaker at our 2011 Reunion, has done extensive research on the Seeley family In the Tioga, PA/Bradford, PA/Chemung, NY tri-counties area.

He believes Montraville and Montelion are children of Adam Seeley, younger brother of Elizabeth Seeley Hetfield and believes Adam and Elizabeth are both children of Nathaniel Seeley, SGS# 189. We had Elizabeth as a daughter of Nathaniel's brother Bazaleel (SGS# 186) and Adam (SGS# 1641) as a son of a different Bazaleel (SGS# 475). We didn't have any children listed for Adam; Kelsey has 10 others besides Montraville and Montelion.

Kelsey also places SGS# 484 Israel Seeley as another son of Nathaniel and shows more children for Israel than we have. He names Israel's wife as Millicent Strong.

The Sarah Seeley we have as SGS# 1705 he places as the youngest child of Nathaniel and corrects her marriage and birth dates.

# 2011 SGS Reunion Souvenir Books For Sale



# SGS to Hold 2013 Reunion in Grand Rapids, Michigan

Members of the National Association of Retired Federal Employees (NARFE) came from all over the country to attend its biennial convention in 2010 in Grand Rapids.

Many had never been to the city and weren't sure what it would be like. They were more than pleasantly surprised.

"The people are friendly. There's lots to see. There's so much within walking distance," said Bette Jensen of Maryland, smiling broadly as she attended a Michigan Night event at the Grand Rapids Public Museum, with blue sky and sparkling river creating the perfect backdrop on a beautiful summer evening.

"And the hotel (the Amway Grand) is gorgeous. It's very elegant. I can imagine it at the turn of the century."

Others raved about having a chance to take in the John Ball Zoo and the Polish Festival at Rosa Parks Circle. Some had gone on side trips to nearby casinos and Michigan's Adventure, while others were planning an excursion to Michigan's Upper Peninsula or a ride on the car ferry out of Ludington when the conference was over.

"I wasn't sure what to expect," said one NARFE delegate, "and look what I walked into: This beautiful city."

This beautiful city also caught the eye of Aaron Wolowiec, education director for the Health Care Association of Michigan (HCAM). Until attending his first convention in Grand Rapids, Wolowiec didn't know the city well. Now he has booked the association's big conventions for 2012 and 2013 here.

"For me, it's a no-brainer," he said. "There are so many things to do. It's sort of a hidden gem."

Paige Pollard, an historic preservation consultant from Norfolk, Virginia, who helped bring the National Alliance of Preservation Commissions' biennial conference to Grand Rapids in 2010, has similar impressions. In the past, the Alliance held its conventions in cities like New Orleans, Baltimore, Indianapolis, Pittsburgh, Denver and San Antonio.

"I appreciate how walkable the city is and how gracious the people are," she said. "I like the integration of the modern buildings with the historic buildings."

Alliance Executive Director Drane Wilkinson of Georgia said the Grand Rapids experience started on a high note and stayed there.

"Our opening reception at the Children's Museum was a blast," he said. "We were surprised by the swing dancing Tuesday night at Rosa Parks Circle. A lot of people enjoyed exploring and looking around the museums and the Wealthy and Cherry Streets corridor. The Cottage Bar was a destination we were told we had to go to (for the town's best burger). All the brew houses were great.

"Some of the cities we visited, you wonder where the people are. Here you go out, and there are people doing things. Grand Rapids is a city that is very alive," said Wilkinson. "It's a friendly, upbeat, nice, easygoing city."

# SGS Members Vote to Change Constitution and By-Laws, Raise Dues

The members present at the July 16, 2011 business meeting of the SGS, held in Horseheads, NY, unanimously approved the changes proposed to the Constitution and By -Laws of the organization as outlined in the February and May, 2011 newsletters. As a result, the fiscal year, terms of officers and dues will be for the period from October 1 through September 30. Officers will continue to serve two year terms.

These changes provide consistency and will allow for a

more accurate fiscal picture of the society year to year.

The new dues structure was also unanimously approved, taking effect on October 1, 2011. The fee schedule is as follows: one year, \$10; two years, \$18; three years, \$25; and five years, \$36. Life memberships will now cost \$125.

Members whose membership expires on August 31, 2011, will have their memberships automatically extended through September 30, 2011.



# Seeley Genealogical Society Constitution and By-Laws

#### Constitution

(Revised July 16, 2011)

#### **ARTICLE I: Name**

- SECTION 1. The name of this organization shall be THE SEELEY GENEALOGICAL SOCIETY, hereinafter referred to as "the Society."
- SECTION 2. The Reverend Garner Osborne is recognized as the founder of the society. Any person who was a member prior to 1965 is a charter member.

#### **ARTICLE II: Objectives**

- SECTION 1. The Society will solicit as members, descendants of the Seeley surname of all spellings to include those who by marriage have acquired another surname, and anyone who has an interest in genealogy. Known surname spelling variants include Seelye, Seely, Selee, Sealey, Seela, Cilley, Ceely, Ceilly, and Ceilley; however, all similar spellings or variants are included.
- SECTION 2. The Society shall engage in research, study, verification, discussion, collation, publication, dissemination, and preservation of Seeley information for the Society, for its members and for posterity. In so far as practical, the Society will respond to all that inquire about Seeley ancestral lines. The Society will receive, hold, and invest appropriate monies, dues, gifts, proceeds from sales, interest, etc., and control and administer any properties for the benefit of the Society. The Society shall publish a periodic newsletter.
- SECTION 3. The Society will establish and maintain associations with societies of other surnames and state and national organizations to encourage interest in genealogy and to benefit therefrom.
- SECTION 4. The Society will pay special recognition to Robert Seeley of England who immigrated to America in anno domini 1630; and to Obadiah Seeley, who appeared in the records of Stamford, Connecticut in 1640.
- SECTION 5. The Society will maintain a National Research Center, co-located with the Seelye Mansion in Abilene, Kansas. The Research Center will collect family and archival records for research by the membership and members of the general public.

#### ARTICLE III: Membership, Dues and Fiscal Year

- SECTION 1. There shall be three classes of membership in the Society:
  - (1) Charter: Persons who participated in founding and administration of the Society prior to 1965.
  - (2) Individual, Library or Society
  - (3) Lifetime
  - Charter, Individual and Lifetime memberships shall apply to a member and spouse.
- SECTION 2. Dues shall be specified in the SGS newsletter subject to revision per Article I of the By-Laws.
- SECTION 3. Any and all references within the Constitution and By-Laws referring to the fiscal year shall refer to the period from October 1 through September 30.

#### **ARTICLE IV: Officers**

SECTION 1. The elected officers of the Society shall be a President, First Vice President, Second Vice President, Secretary, Treasurer, Chief Genealogist, and three Directors elected from the general membership.

The President shall appoint an Ancestor Files Chairman, a Membership Chairman, a Publications Editor, Assistant Genealogists as required, and a Director for the National Research Center.

All elected and appointed officers of the Society may be of either gender without exception. Throughout this document the use of the masculine pronoun should be considered in the classical sense to apply to both male and female genders.

- SECTION 2. Officers and Directors of the Society shall be elected for a term of two years. The election is to take place at the national reunion. Officers and members in good standing are eligible to vote. A quorum of 25 members is required to elect.
- SECTION 3. The officers' and directors' term of office shall begin on October 1 following the election or reelection of officers and directors at the national reunion.
- SECTION 4. No member shall hold more than one office at a time, except for short times resulting from succession to office as provided for in Article IV, Section 5.
- SECTION 5. In the event of the resignation or incapacity of any officer, except the President or a Vice President, the vacancy will be filled by a majority vote of the remaining elected officers. For the unexpired term, of the President and/or a Vice President, succession will be automatic from the remaining elected officers in the order shown in Article IV, Section 1 above, exclusive of the Treasurer.
- SECTION 6. The elected officers and directors shall constitute an Executive Board.
- SECTION 7. If there is more than one nominee for any office, elections shall be by secret ballot, and a majority of those voting shall elect.

#### **ARTICLE V: Meetings**

- SECTION 1. The membership shall meet at least every two years, as specified in the By-Laws. Business of the Society may be conducted if there is a guorum present at the reunion.
- SECTION 2. The officers and Executive Board shall meet as specified in the By-Laws and serve without monetary compensation.
- SECTION 3. The order of business at all meetings will be governed by Roberts Rules of Order, Revised. The President may appoint a Parliamentarian, who will serve at the pleasure of the president.
- SECTION 4. To conduct business of the Society, a quorum of 25 members will be required. Five elected officers constitute a quorum of the executive board.

#### **By-Laws**

(Revised July 16, 2011)

#### **ARTICLE I: Dues and Membership**

- SECTION 1. It shall be the responsibility of the Executive Board to periodically review the dues structure to ensure the fiscal integrity of the Society. Changes proposed by the Executive Board must be approved by a three-fifths majority vote of the membership at the national reunion, subject to quorum requirements. Dues are to be paid to the Membership Chairman, who will issue a membership card and forward dues plus appropriate documentation to the Treasurer. The fiscal period for dues shall coincide with the Society's fiscal year.
- SECTION 2. Membership will be awarded as specified in Article II, Section 1 of the Constitution.
- SECTION 3. Membership may be refused or suspended by a three-fifths vote of the Executive Board to anyone or any organization, whose interests conflict with the purpose of the Society.

#### **ARTICLE II: Meetings**

- SECTION 1. The President, with the approval of the Executive Board, shall call meetings of the Board and the general membership subject to the minimum requirements of the Article V, Section 1 and 2 of the Constitution.
- SECTION 2. It is recommended that the President call a meeting of the Executive Board each year in the month of August or at a mutually agreed upon time. The Society recognizes the geographical dispersion of the officers and directors. The President may present to and solicit from officers and directors public mail responses to questions, programs and reports necessary for the administration of the Society. These are to be reported to the membership in the newsletter. The in-person meeting of officers and directors is encouraged when it is practical.
- SECTION 3. Six (6) of the officers and board of directors may call a special meeting of the officers and directors for consideration of issues. A special officers and directors meeting may also be called by twenty-five members of the Society by signed petition, at no expense to the Society. Quorum requirements will apply

#### **ARTICLE III: Duties of Elected Officers**

SECTION 1. The President shall be the chief executive officer of the Society and preside at all meetings. He shall be a member of all committees except the nominating and auditing committees. The President is authorized to approve disbursal of reasonable fund amounts from the Treasurer's account(s) for the routine operation of the Society business, to carry on correspondence and to publish the newsletters. The President shall serve as the chairperson of the committee to organize the membership meeting conducted per Article V, Section 1 of

the Constitution.

- SECTION 2. If the President determines that an elected officer or director is not performing the duties for which elected, he may request the Executive Board remove the member. Such removal will require a three-fifths vote of the eligible Executive Board members.
- SECTION 3. The First Vice President shall perform duties assigned by the President, preside and perform all duties necessary in the absence of the President, and assume the Presidency if the office becomes vacant.
- SECTION 4. The Second Vice President shall perform duties assigned by the President, preside and perform all duties necessary in the absence of the President and First Vice President.
- SECTION 5. The Secretary shall record and preserve the minutes of the meetings of the Executive Board and of the reunions. The Secretary will perform other administrative duties as assigned by the President.
- SECTION 6. The Treasurer shall safeguard the funds and maintain all accounts in the name of The Seeley Genealogical Society. He shall be responsible for adequate financial records. When the Executive Board shall determine bonding is required, this will be done at the expense of the Society. If investment of funds of the Society is made, approval of the Executive Board is required.
- SECTION 7. The Chief Genealogist shall have custody of the genealogical files of the Society and maintain such other files necessary for the performance of his duties. He will safeguard them from common hazards. The duties are those generally accepted as responsibilities of a genealogist. He will be assisted by genealogists appointed by the President. He shall comply with the requirements of Article II, Section 2 of the Constitution. He shall also work closely with the Director of the national Research Center to assure that all Society records are copied and/or archived at the Center for researchers' use.
- SECTION 8. Directors: The three Directors shall serve as representatives of the general membership. They may be assigned duties by the President to assist in the administration of the Society.
- SECTION 9. The immediate past President shall be an ex-officio member of the Board of Directors and committees in a non-voting advisory capacity.
- SECTION 10. The President, with the approval of the Executive Board, may establish other positions and collateral duties not named elsewhere.

#### **ARTICLE IV: Duties of Appointed Officers**

- SECTION 1. Publications Editor: The Publications Editor shall be responsible for the organization, printing and mailing of the quarterly newsletter. The newsletter shall include inquiries submitted to the Society for general membership response. The closest liaison must be maintained with the Membership Chairman and the Chief Genealogist to perform these duties.
- SECTION 2. Ancestor Files Chairman: The Ancestor Files Chairman shall be responsible for maintaining a computerized database of all ancestor files submitted by members of the Society. He shall also be responsible for responding to inquiries to the Society regarding established lineage.
- Research Center Director: The Research Center Director shall be responsible for maintaining the National Research Center in Abilene, Kansas, as a resource to Society members and members of the General Public. He shall act as an advisor to the President and to the Chief Genealogist.
- Membership Chairman: The Membership Chairman shall be responsible for the promotion of the Society membership, maintenance of membership rolls, and collection and forwarding of dues to the Treasurer. He shall be appointed by the President from the membership, exclusive of the Treasurer.
- SECTION 5. Assistant Genealogist: Assistant Genealogists, when appointed, will be responsible for specific tasks in support of the Chief Genealogist's function.

#### **ARTICLE V: Committees**

- SECTION 1. The President shall appoint necessary standing and ad hoc committees and require reports from them.
- SECTION 2. Nominating Committee: The President shall appoint a nominating committee of at least two (2) members one year in advance of the national reunion. The Nominating Committee shall ascertain that all candidates nominated will be willing to serve if elected. The election shall be as provided in Article IV, Section 2 and Section 3 of the Constitution. Nominations may be made from the floor for all offices with the consent of the nominee.
- SECTION 3. Auditing Committee: The President shall appoint an auditing committee of not less than two (2) members to examine the financial records of the Society, once every two years, or oftener if required by the Executive Board. The results will be presented to the membership in attendance at each reunion, and submitted in writing for publishing in the newsletter.

#### **ARTICLE VI: Amendments and/or Revisions**

Amendments and/or revisions to the Constitution and the By-Laws will require approval by a three-fifths majority vote of the membership at a national reunion subject to the quorum requirement. All proposed changes must be printed in the newsletter for membership review a minimum of three months prior to the reunion.
