## Membership Chair's Update

The SGS Board's Membership Plan to deal with our declining membership, approved during the June 2019 Reunion, is being implemented.

An email or mailed letter was sent to each and every SGS member asking for ideas on how we can make SGS more valuable to its members. To date, we have received 23 member responses containing a lot of ideas. I'm hoping for many more.

This plan is envisioned as a continuous one, i.e., collecting ideas and implementing those that hopefully will improve the value of SGS to its members now and in the future. So ideas are not only welcome, but needed!

I analyzed the responses and sent my analysis to the SGS Executive Board along with a copy of all ideas received to date, for the development of an implementation plan (Part C of the approved Membership Plan). Here is where we stand so far to make SGS a more valuable society to its members:

 15 Copies of the SGS New Member's Notebook have been mailed to new members and some others involved in its development. This Notebook contains four sections defining "Who We Are" followed by nine sections describing "SGS Resources Available to Assist" our Members. Change One from the original version most significantly describes 1) how Y, mitochondrial, and autosomal DNA testing, and 2) an understanding of how the Seeley Ancestor File can help SGS members. I've concentrated on using words that highlight the value of the resource rather than the biology or technical aspects of it. More improvements to the SGS New Member's Notebook are needed and will be completed.

- 2. Pam Turner and Paul Taylor modified the SGS membership application to combine it with an SGS product order form, with all forms and money going to the SGS Treasurer, who then forwards the forms to the appropriate SGS officers for action. Although this adds work for the Treasurer, it streamlines the response process, reducing response time.
- Several ideas are under consideration by the SGS Executive Board and in various stages of implementation:
  - a. SGS may fund research on members' brickwalls; a criterion is being developed to help the Board determine which ones to fund.
  - Revise focus of SGS reunions; nine members' ideas are being combined with the evaluation forms submitted by attendees of the 2019 SGS Reunion.
  - c. Increase use of Facebook. Six members suggested using Facebook to update members on a more timely basis.
  - d. Educate and encourage members to use DNA testing to find cousins, particularly

the autosomal DNA tests offered by a few laboratories.

- e. Incentivize joining SGS. Nine members offered ideas, some of which have not been tried before.
- f. Prioritize keeping current members. This was suggested by five members. The SGS Executive Board is considering making the SGS New Member's Notebook available to ALL members.
- g. Focus more on the younger generation was suggested by four members.
- h. Encourage volunteerism by being more specific about the Society's needs. The SGS New Member's Notebook lists many areas of SGS work that could use some help.

### Welcome and Announcements: Lynda Simmons

Lynda Simmons welcomed all in attendance and thanked everyone for helping with the 2019 SGS Reunion, noting that sixty-seven individuals had registered.

She also thanked the staff of the Mormon Battalion Visitors Center and the Cosmopolitan Hotel, all involved in the reunion planning process, and members of the Executive Board.

She reviewed various reunion matters, including box lunches, evening meals, tours, schedule, and the annual reunion photograph, which will be taken on Saturday morning.

**Minutes**: Minutes of the 2018 SGS Executive Board Meeting, April 27, 2018, and April 28, 2018, were read, with one correction noted; the minutes were unanimously approved as corrected.

Seventh Generation Book: Pam Turner, SRC Librarian

- The Seventh Generation Book is currently being revised to reflect corrections by Kathie Olsen and Linda Crocker, and information on errata is available to interested SGS members.
- Errata for both the Nathaniel and Obadiah sections have been included in the revised edition, where possible.
- The foreword has been revised, but the original index will remain

unchanged.

- The Board recommended that the revised Seventh Generation Book be reprinted, the price to remain \$35.00 to cover printing and mailing costs.
- Terry Tietjens will investigate printing ten more copies of the Sixth Generation Book.
- The Board decided the revised book should note that evidence, derived from research by Apryl Cox, indicates that William was the father of Obadiah.
- Jesse Crisler commended Kathie Olsen who with her mother compiled the Seventh Generation Book



**DNA Test Requests**: Lynda Simmons

- Linda Crocker reported that only a few individuals have been tested via the Y-DNA process.
- The Board determined that Y-DNA testing should be considered when a male could be a Seeley.
   Family Tree DNA Update: Wesley Waring, Director
- The SGS-related site on FTDNA has been removed from control of the SGS by a specific individual.

- Wesley has spoken with FTDNA to resolve the issue.
- As of June 2019, Dee Bardis remains the proctor of the FTDNA/Seeley Lineage Project.

I've had to resort to asking Chris Havnar to search local obituaries; I've even called an Episcopal church and a real estate agent to find lost members. An alternative point of contact would make it a lot easier to locate you if we lose track of you.

Also, if you haven't already done so, please send your ancestor line and family information to SGS Chief Genealogist Linda Crocker (contact info on page 15). The more family info we have the more valuable the Seeley Ancestor File becomes to our members.

I appeal to an SGS member to contact SGS President Lynda Simmons and volunteer to relieve me of Membership Chair duties. However, I would still like to serve on the committee to improve our overall membership rolls and increase the value of our society to our members. Meanwhile, SGS Assistant Membership Chair Connie Birth has been a big help, even though living in tornado alley has caused her a number of phone, Internet, and computer problems.

## **How Can I Help SGS?**

It makes sense that volunteers contribute to the strength of organizations like the Seeley Genealogical Society. We are a nonprofit organization; we do not sell products or services for profit; we do not have a political or religious belief to convince others of. We want to help SGS members achieve their goals of learning more about their ancestors.

Just asking for volunteers in the past has not helped as much as we would have liked, so listed here are some positions, talents, or interests members may have that could be used to help fellow members. If you match any of them, please let SGS President Lynda Simmons know, and she will connect you with the SGS Executive Board and officers or members of SGS who can use your help.

- Membership Chair (The • incumbent is doing this on an interim basis until we find someone else to take the job.)
- Newsletter Editor. When the current SGS Executive Board term ends, Paul Taylor will have been editing the SGS Newsletter for 18 years. He understandably believes a change might be needed and also thinks the newsletter could benefit from a new eye. If you would like to take this task on, Paul would be happy to provide a thorough turnover and training to make sure you're set up for success.
- Research Y-DNA, mtDNA, or • autosomal DNA for ways to make this science more useful to SGS members through their knowledge and advice.
- Use a variety of tools, energy, and

initiatives to track down members who may have moved, or for a number of reasons SGS has lost ways to communicate. The idea is to set as a priority keeping the members we have, rather than losing them just because they moved and forgot to let us know their new contact information.

- Analysts who have the ability to assemble genealogical data collected from a number of sources, maybe even provided by SGS, and then can point the way forward for a member to pursue more research.
- Suggest common sense criteria for the SGS Executive Board to use in deciding which members' "brickwalls" should qualify for SGS research funds.

If you can help in any of these areas (or in an area not listed), please contact SGS President Lynda Simmons (contact info on Page 15)

- Assist the SGS Secretary in tracking action items, providing the Executive Board status of action taken, ensuring a person is designated to take the action, performing follow-up, reminding members of action item completion when the issue appears again, reporting periodically on how many and which action items remain open.
- Track metrics, like total SGS assets, total SGS membership, and other information that measure the health of the Society. Keep the SGS President informed for the

biennial "State of the Society" report delivered at each Reunion.

- Solicit and analyze members' • ideas for those most likely to positively influence growth in the health of SGS and its goals.
- Assist with the objective of • "documenting SGS" by helping with Newsletter content and publication, the Reunion Souvenir Book content and publication, use of Facebook and other social media to communicate with members, and website content and organization.
- Develop ways for members to pay their dues online, pay for documents or items SGS offers for sale online, or pay for a papercopy subscription to the SGS Newsletter.
- Improve ways to notify members when their periodic financial commitments are due.
- Assist with the collection and recording of Seeley data in SGS databases.
- Provide advice and/or assistance to the SGS Treasurer on how to manage SGS funds from collection, investment, paying bills, reporting financial status, and preparing or performing audits.
- Teach elements of genealogy • during SGS Reunions.
- Assist with planning for effective • and interesting SGS reunions to include: selecting speakers; planning an agenda that helps attendees learn more about each other; offering attendees the opportunity to report challenges they face in learning more about

## How Can SGS Help Me? The Seeley Ancestor File

Editor's Note: There are a number of SGS resources that might be of value to you in your Seeley genealogical research. In coming issues of the SGS Newsletter, we'll refresh your memory with information about those resources. Be sure to tell your cousins about these resources and encourage them to become members of SGS.

The Seeley Ancestor File was started by volunteer John R. Seely who served as SGS Vice President (1986-1995) and the appointed SGS Database/Ancestor Files Coordinator (1995-2011). It is now maintained jointly by volunteer SGS officers Chief Genealogist Linda Crocker and Assistant Genealogist Chris Havnar.

There are two lists. The first is the <u>SEELEY Children alphabetical list</u> in which the following information is provided when known:

- In this list, since all entries are Seeley surnames, ONLY given names are listed in alphabetical order
- The descendant's generation

## A Great, but Simple Idea

Most newsletter readers will recall that I sent out, in May 2019, an appeal for ideas on how we might turn around the declining SGS membership. Well, I received several good ideas, but there is one that I thought was worth sharing.

A senior (I believe) SGS member from Florida wrote me a handwritten letter that proposed I call him so we could discuss his idea, so I did. His idea was profoundly simple. He said, "If you send me several copies of the SGS Membership Application, I will pass them on to the officers of my number ONLY for those descendants of either immigrant Robert or Obadiah Seeley

- The SGS number, if descended from either Robert or Obadiah Seeley
- The descendant's year of birth, and town, county, and state where born
- The descendant's year of death, and town, county, and state where died
- For the descendant's marriage, the spouse's surname followed by the given name, year of marriage, town, county, and state where married
- The descendant's mother's maiden surname, followed by her given name,
- The descendant's father's surname, followed by his given name
- File number(s) or source code(s) that identify the source of the information listed in the data fields described above

Seeley group who meet annually in Painted Post, New York," and ask them to give them to prospective Seeley descendants.

Guess what? Following that conversation, I have since received word of two new members, one from Painted Post, NY, and another from Lyons, NY. I don't know with 100 percent certainty whether they were the result of that gentleman's idea, but I think they may be.

That gave me the idea of including a few SGS Membership Application forms in the SGS New The second list is the <u>NON-</u> <u>SEELEY Children alphabetical list.</u> The data fields are the same as the SEELEY Children alphabetical list EXCEPT:

- The surname is listed alphabetically, followed by the descendant's given name
- The TOWN is NOT listed for any of the data elements.

These are currently in searchable MS Excel files, but since they contain so much information on living Seeley descendants, they must be kept private. Access is available via the SGS Chief Genealogist.

If you have a copy of the three Generation Books, either on CD or in paper form, you can help find your way through a "brick wall" by including a likely SGS number in a query to the SGS Genealogist. However, even without a suspected SGS #, the SGS Genealogist is willing to use the database and other available information to assist a person in locating ancestors.

Member's Notebook for the recipient to pass on to prospective new members. I'm thankful and impressed with the idea and initiative of that SGS member from Florida.

Editor's Note: I'm very interested in sharing stories highlighting discussions about genealogy or our Seeley family history, such as a distant cousin helping your research, or a story about a Seeley ancestor that you haven't heard of before, or a genealogy tip you might wish to share with our members. 

## 19th Century Transportation and Old Town San Diego's Seeley Stable

From California State Parks

Editor's Note: The 2019 SGS International Reunion in San Diego, CA afforded attendees the opportunity to learn about the history of the region, as well as Seeley family history. The Seeley Stable is one of the structures in Old Town San Diego State Historic Park (learn more here: parks.ca.gov/?page\_id=663). It was a key part of the stagecoach business of Albert Seeley and is located nextdoor to his Cosmopolitan Hotel.

#### THE STORY

During the 1800s, travel time in California was measured in days and weeks. Before the first railroads in the state were completed in the latter part of the century, the mainstay of commerce was the stage line. Typically, a local enterprise consisted of teams of horses and wagons. Drivers braved whatever came along to transport passengers, freight, and mail.

Stagecoach travel was always risky, even on the best of roads. Apart from holdups and bad weather, the newspapers of the day told frequently of disastrous accidents. Bad ruts, rock slides, and overflowing creek beds were common sources of trouble, often resulting in major detours or worse. Albert Seeley lost one of his stages in 1876 when it was swept into the sea along the San Onofre Creek.

Stage Lines in California generally had their start during the Gold Rush boom. Using all sorts of wagons, independent lines began to connect San Francisco with San Jose; Sacramento with Stockton, Marysville and Virginia City; and Mother Lode towns with Portland, Oregon. The

first stage line between Los Angeles and San Diego began in 1852.

Mail service between eastern cities and California began in 1850, but not until 1857 was a mail route approved between San Antonio and San Diego via Yuma. This stage line, officially called the "San Antonio and San Diego Mail," was also derisively called "The Jackass Mail" because mules were used to pull the stage. Parts of the route were so rough, it had to be traversed by pack mule.

In 1861, the same year the San Antonio and San Diego Mail stage line ceased operation, Wells Fargo and Company began to acquire control of western stage lines. In little more than a decade, railroads would become the principal mode of transportation. However, communities like San Diego, which were not immediately located on a railroad, still had to depend on a local stage service a little while longer.

#### THE BUILDING

The original Seeley Stables was built circa 1869 to support the transportation services offered by Albert L. Seeley. Horse stables typically would have horse stalls, wagon storage, and tack rooms on the ground floor, while feed and straw would be hoisted to the top floor for storage. The current museum has three large areas: the main floor, the upstairs loft, and the outside yard. One area on the main floor is set up to resemble a 19th century express office. Items of western memorabilia on the second floor and many of the wagons were donated by Roscoe E. "Pappy" Hazard, a San Diego transportation and highway construction pioneer of the first half of the 20th century.

The exhibits on the ground floor contain several rare examples from

California's early wheeled transportation history. One of the earliest is an original ox-drawn carreta from the Spanish Period. Across from it are a pair of massive freight wagons. Farther back in the exhibit is a Concord "mud wagon" stagecoach. There were two distinct classes of Concord coaches, with a number of variations. The mud wagon was particularly suitable for the rough and rocky terrain of Southern California.

Among the western memorabilia upstairs are a number of items that relate to Southern California. The California vaguero and saddle displays will give you a sense of San Diego rancho life during the Spanish and Mexican eras. The branding iron, like many other tools and words in the cattle industry, finds its origins in Spanish ranching.

The original Seeley Stables was demolished in 1920. The Seeley Stable Museum is a 1974 reconstruction by California State Parks.

The yard in back contains covered wagons and sturdy freight wagons that were once used to haul people and goods long distances. A large collection of horse-drawn buggies, surreys, carts, and carriages is housed in the two out-buildings in the courtyard. In addition, the yard has two resident donkeys.

#### **THE PEOPLE**

Albert Lewis Seeley (1822-1898) was born in Illinois. A stagecoach driver since 17, he had worked in Texas and Los Angeles. In 1867, Seeley came to San Diego with his Englishborn wife, Emily, and their six children. He soon began the United States Mail Stage Line. In 1868, the U.S. government

granted mail service over the Tucson to Los Angeles route via San Diego. Seeley was awarded a contract for the San Diego to Los Angeles run. In addition to the two-day, tri-weekly

mail and passenger service to Los Angeles, Seeley's stage line also provided service between San Diego and Yuma.

On May 1, 1869, to provide a depot and accommodations for his line, Seeley purchased the former Bandini residence for \$2,000 in gold coin. He added a wooden second story to the adobe structure and renamed it Cosmopolitan Hotel.

The new hotel served as a local social center as well as a stage stop. The San Diego Union stated that it was "one of the roomiest and most comfortable hotel buildings in Southern California." Also at this time, Seeley constructed this stable barn adjacent to the hotel.

Seeley's business prospered during the following decade. In 1871, he expanded to Los Angeles mail and passenger service six days a week. Also, he purchased the Blackhawk Livery Stable. Three years later he contracted with Wells Fargo and Co. to run his coaches tri-weekly to gold mines in the Cuyamacas and weekly from Julian to San Bernadino. Seeley was also awarded a four-year contract to deliver mail to Julian, leaving from the Cosmopolitan Hotel on Mondays and Fridays.

Seeley's business declined steadily over the next decade as railroad lines spread throughout the state. By 1887, Seeley had ceased running stages except for a local line between San Diego and Ocean Beach. That same year, he sold the Cosmopolitan Hotel and the stable for \$15,000 in gold coin. Seeley and his wife moved to San Francisco in 1895.

## Query Updates:

**Update to Query 1902-2** Submitted by Lynette Fowlston (clynpnt@charter.net)

Lynette is still trying to determine the origins of Isaac Seely/Seeley who was b. in 1812 in NY. He appears in the 1850 census of Parke County, IN, with his wife, Mary Owens Seely, and their six children. There is a record on Findagrave that shows him dying in 1851 at age 39 years, 10 months, 22 days. The cemetery record says he had a brother Charles D. Seely (but no further information) and wife Mary A. Owen. There is no source information, and I can't locate a Charles D. Seely in any other record.

There is also a census record in Parke County in 1840 that shows Isaac, age 20-30, with one son under five, one daughter under five, and a wife, age 20-30. Various online trees identify his father as Israel Seeley, SGS#1608, but we don't list Isaac or Charles as his children. We welcome any help you can give us.

## Update to Query 1602-3 Submitted by Candace Wilmot (<u>cwilmot@illinois.edu</u>)

Candace is still trying to locate the parents of her 2<sup>nd</sup> great-grandmother Almena Clifford, who was b. 1803 in Norwalk, CT, and died 27 Jan 1882 in Serena, LaSalle, IL. We recently received more information.

Candace says, "Because she named her first child Joseph Seeley Clifford, I have always thought that might have been her father's name. Her mother, Polly (unknown) (Seeley?) Wheelock, accompanied John and Almena when they moved to Illinois in 1850.

"There is a Joseph Seeley documented in

Plattsburgh, Clinton, NY, who died 25 December 1919 at age 41. The only other mention of this Joseph in Plattsburgh is three notices in 1917 and two in 1919 stating letters for him are held at the post office.

"On 10 NOV 1818, a death notice appeared in the *Plattsburgh Republican* for a nine-year-old Polly Seely, daughter of Joseph. The *Republican Farmer* in Bridgeport, CT, was requested to republish this for the connections in Norwalk.

"The 1820 census shows Polly Seely in Plattsburg with one female in her household who is the right age to be Almena."

SGS Response: as noted in the original query, Almena and her husband, John Clifford, were listed in the 1850 census in both Ottawa, Lasalle, IL, and Plattsburgh, Clinton, NY (where Poly Wheelock, age 64, is also listed with them). They were also in Clinton in the 1840 census.

Research commissioned by Jim Seeley, former SGS President, helped us recognize that children listed under William #1692 in the 7th generation volume actually belong to SGS #1595. William #1595 is the William who married Fanny Gray. William Henry has been assigned SGS # 3699d. This information appears in the latest (2019) edition of the 7<sup>th</sup> Generation volume (an example of one of the many corrections made), along with information on William Henry's 12 siblings (numbered SGS#3691-3699 plus 3699a, b, c) and their mothers, the wives of SGS# 1692. #### Martin N. Seely Claimed by Death, Fair Hill Man Dies At 85

MONTROSE, July 8 - Martin Nicholas Seely, 85, one of the best known farmers in western Susquehanna county, died at his home at Fair Hill on Tuesday morning at 1 o'clock. Mr. Seely had been in ill health for some months, due to a nervous ailment, and his condition became critical less than a week prior to his death.

He was a native of Kirkwood county, Mo., where he was born Dec. 31, 1846. His father died when he was nine years of age, and his mother came to Niven, Wyoming county, with her children to be near relatives. After attaining young manhood, he conducted a feed mill at Lynn, this county, for fourteen years and later resided in West Nicholson and Dimock before buying a farm at Fair Hill thirty years ago and locating there. He married Mary Susan Green on July 1, 1874m and her death occurred in September 1920. The following children survive: Mrs. I.C. Parker, Giles G. Seely, Fairdale; Mrs. Reed H. Raub, Mrs. Charles Steiger, Forest Lake, Pa.; Mrs. Myron Green and Clude F. Seely, Fair Hill. One brother and four sisters preceded him in death. The funeral was held from his late home this afternoon. Interment was in South Montrose cemetery.


