Abilene resident, Terry Tietjens was recently honored with the Edwin P. Hubble Medal of Initiative in Marshfield, Missouri, during the Missouri Cherry Blossom Festival. The award, which was first presented to Lady Bird Johnson in 2004, is the city of Marshfield's highest honor and is presented annually to honorees who have shown great initiative in their chosen field. The award is presented by the Hubble Legacy Committee and the Missouri Cherry Blossom Festival.

The 2022 class of honorees included Tietjens, who was honored for his work in restoring and preserving the historic Seelye

Mansion, Rebecca Holden from the classic television show "Knight Rider," Ruta Lee, a classic actress of both television and screen, and Nancy Stafford of "Matlock." John Collett was also honored during the festival with the medal for his work in the armed forces.

Tietjens was introduced at the award ceremony by fellow Abilene resident, Mary Jean Eisenhower, granddaughter of President Dwight Eisenhower and a 2017 recipient of the medal.

Throughout its history, the award has been presented to many outstanding Americans, including

I was asked to explain in less technical terms our new DNA project, why we want everyone to join it, and how using DNA is helpful in researching. To me DNA is like a big pot of stew, which

is then served in individual bowls. It all comes out of the same pot, but not everyone will get the exact same number of carrots or potatoes in their bowls. When searching for the DNA of our ancestors, we are searching for those bowls of carrots and potatoes, which originally came out of that same pot. Finding them proves that they all came from the same pot; then the pieces of the puzzle all fit together, once again becoming a picture or family. The more children a family has the more DNA is out there, waiting for us to find it. Families who remain in the same

location for generations are sometimes easier to trace, but a lot of people have ancestors who moved often, lost everything, and are now all over



the country or even world. All of us have lost sheep in our families. They could be living down the street from

> cousins, or have worked with someone to whom they later found out they were related. Researching to find these family members, to read the stories, to learn about people who lived decades ago, and then to learn that they are your people is a great discovery and a reason to keep searching for those missing relatives. There have been times when I have gotten in touch with people who knew no relatives beyond their immediate family and were very grateful to learn

about their family history. If you have completed a DNA test for FamilyTree DNA, regardless of which DNA test, please join the new SGS project. If you want more information about which DNA test to take or transferring your DNA from another site, please call or text me. Let me know whether you found this explanation helpful.

Obituary: Chris Havnar, SGS Director, Asst. Genealogist, Webmaster

Joanne Christine
"Chris" Kjeldgaard
Havnar was born June
10, 1951, in San
Diego, CA, to Peter
Dean and Elizabeth
Seely Kjeldgaard. She



married her husband, Jerry (Gerald Edmond Havnar), in 1980, and they lived in Pacifica, CA. They had one son, Charles, and two grandchildren, Nathan and Sophia, as well as a stepgrandson, Ernesto.

Chris and Jerry shared childcare for their grandchildren with the other grandparents, and after Jerry's death in 2015, Charles, Nathan, and Sophia moved in with Chris. Chris died on March 8, 2022, shortly after being diagnosed with cancer. Besides her son and grandchildren, she is survived by a sister, two brothers, and their families.

Chris was a fixture at Seeley

Genealogical Society Board meetings for almost twenty years during which she served in a number of leadership positions. Although her work brought her in contact with all appointed and elected members of SGS, the person with whom she worked most closely was SGS Chief Genealogist Linda Crocker.

"I met Chris at my first SGS Reunion in 2005 in Abilene, and knew I had met a kindred soul," said Crocker. "Chris was already serving as the SGS Treasurer at that time. By the 2007 Reunion Chris and Jerry were managing the SGS Website, which Jerry had redesigned, and in 2011 Chris added co-chairing the Ancestor File to her duties.

"Chris spent innumerable hours searching for and recording Seeley vital statistics, primarily in California and Oregon as well as collecting Seeley obituaries, wedding notices, and all kinds of other Seeley information for the SGS Website. As Ancestor File Co-Chairs, we had agreed to check each other's entries, but I quickly fell behind, since she contributed so much. I was grateful to be able to have Chris stay with me when she came to Parkersburg for the 2017 Reunion, which turned out to be her last."

SGS Librarian Pam Turner enjoyed her time with Chris as well and said, "If you ever had the pleasure of meeting Chris, you know that the world has lost a special lady. For SGS and genealogical research in general, a powerhouse in finding information is gone. Her support of SGS was extraordinary."

"My first knowledge of Chris came before I had even met her," said Turner. "On a visit to the research center in Abilene, KS, I discovered the binders Chris had put together filled with California death certificates and obituaries. It was in these binders that I discovered that an ancestor didn't die in Southern California, as I had thought, but in Northern California.

"This discovery prompted me to want to help in the SRC and eventually led to me becoming its librarian. When I finally met Chris, I had to tell her how those binders had helped me and thanked her for them.

"As time went on, and I got to know Chris better," Turner continued, "I realized how important family was to her. Not just her own, but everyone else's as well. This was shown through her love of research and wanting to share that research with everyone.

"She was great at finding obituaries. One memory that makes

Report: Seelye Research Center Librarian

I was recently presented with a challenge by a person who contacted our Website with a question about a book signed by Mr. Sherman Seeley. The questioner wanted to know how his grandfather, William Smith (formerly Schmidt), had ended up with the copy, and whether we could tell if they knew each other. He gave me the information he had collected, mostly obituaries from the Seeley Website, and I used that information to begin my hunt, which centered on Huron, SD.

I went through census records for Huron from 1900 to 1920, looking for both Sherman and William. I found Sherman F. Seeley in the 1900 and 1910 censuses, living with his parents in Lake Byron (Huron?), Beadle County, District 0018; he was aged ten and twenty and was listed as being a farmer in the 1910 census. In the 1915 SD census he is living with his wife, Orpha, but the city was not

listed. I could not find Sherman on either the 1920 census or the 1925 state census. By 1930 the family had moved to Becker, Sherburne, MN. I know they were in Huron in 1919 because their middle son was born then and lists Huron as his birthplace. Sherman's WWI draft registration card was also completed in South Dakota.

As for William Smith, I found him in the 1920 census in Huron Ward 3, district 0296, Beadle County, SD, living with his wife, Anna, and four sons. He is also listed on the 1915 SD state census but did not list the city where he is living. In 1910, I find him as William F. Schmidt in Spink, SD.

My conclusion was that if these two men crossed paths, it would have been between 1910 and 1920. I looked over the actual census sheets and discovered that they did not live close to each other. Based on their age differences, job differences, differences in their children's ages, and no apparent connection in any census, I would have thought that they never connected. Since Smith worked for the railway as a station agent, I think it probable that the book was left in the station, and that was how he acquired it.

Of course, my conclusion could be one of many, but this challenge presented a different way to think about genealogical research: could a connection be found between two unrelated families from the early 1900s? It showed me that families moved more than I had thought, and it helped me understand how to navigate Ancestry a bit better. So even though I could not connect these two families directly, my search improved my research skills and made me think outside of the box, regarding genealogical research in general. I was thankful for the challenge.





Sherry is a pedigree researcher and Appaloosa breed historian. She came across the genealogy site for J. Leo Seely in connection with Appaloosa horses. She saw where his family bred purebred sheep and cattle. She says that J. Leo Seely has a registered Appaloosa horse credited to him. The horse is named Spangle, ApHC F31, foaled in 1937. He was a black/white blanket with black spots. His sire is listed as an unregistered horse named Spot; his dam is listed as an unregistered horse named Mathelda. J. Leo Seely is listed as the breeder of this horse. If you go to https://appaloosaterritory.com/Articles/ foundation1.html (or just search for Appaloosa Territory, then go to "foundation numbers" 1-100), and scroll down to F31, you can see the information and photo of this horse. Sherry is wondering whether there is any other information or photos about horses (particularly Appaloosas) that J. Leo Seely may have owned and/or bred. She says that there is a registered Appaloosa mare named Manti-Sue ApHC T4453, bred and owned in Utah, that is shown as sired by Seeley's Appaloosa. There are several descendants of this mare in Utah, according to registry records. She is hoping for some sort of information about any possible horse breeding program J. Leo Seely may have had.

SGS Response: Findagrave has a memorial for John Leo Seely (1887-1971). It mentions that he died of head injuries when he fell off his horse and that he was an "employee of the Dept. of the Interior, working with Indians" (https://www.findagrave.com/memorial/143394/john-leo-seely)

We also have his obituary on our website: http://www.seeley-society.net/obits-ly/obit-johnleoseely.html.

John Leo is a descendant of Justus Azel Seeley (SGS# 836). It turns out that he is in former SGS President Lynda Simmons's line, so I asked her for help. She replied to Sherry: "Leo inherited his parents' home in Mount Pleasant, Utah. My husband and I stayed in that house the night before we were married. Leo's parents were John Henry Seely and Margaret Folkman Peel, and they built the

home. John Henry Seely's parents were Justus Wellington Seely (SGS# 2237) and Clarissa Jane Wilcox.

In FamilySearch.org there is a picture of Leo, his wife, Edna Lucile Rolph, their two daughters, Ina and Chesla, and grandchildren. My mom loved Ina and Chesla. I remember Leo looking the same as he does in that picture. There are many other pictures and memories of him, including one that said Leo died of a kick in the head from a horse he was training." Lynda encouraged Sherry to explore all the information on Leo and his family available at FamilySearch.org.
